**OFFICE MEMORANDUM**

It has been observed that staff and officers are coming late, leaving office early without proper authorization and absence of certain employees are not being communicated to Administrative authority in a timely manner. The practice of regularizing the absence of employees after their joining duties should be stopped forthwith. It has also been observed that some of the employees (Officers & Staff) are not adhering to the office timing. The office working hours has been communicated vide this department Office Memorandum conveyed under Memo No. F.20012/1/2021-LADC/GAD Dt. 29<sup>th</sup> September, 2021. Every employee should mark their attendance as per the timing given below.

**Morning - 09:00AM**

**Evening - 17:00PM**

Hence, all employees are hereby informed that Office timing should be strictly adhered to. Every employee is expected to be in seat and to start work at the prescribed opening hour. Ten minutes grace time may be allowed in respect of arrival time to cover any unforeseen contingencies. Such late coming (within the grace time) may be condoned unless it becomes matter of frequent recurrence.

Further, it is also informed that as per rules, Half-a-day's casual leave should be debited to the Casual leave account of an employee for each late attendance, but late attendance up to an hour, or not more than two occasions in a month, may be taken against the employee concerned in addition to debiting half-a-day's casual leave if he/she is persistently/habitually attending late/leaving early.

This issues with the approval of the competent authority.
