NOTIFICATION

No. C.11013/3/2019-DC&MA (L), the 7th **April, 2021:** In pursuance to paragraph 11 of the Sixth Schedule to the Constitution of India, the following Rules duly approved by the Hon'ble Governor, Mizoram on 26.03.2021 is hereby published for general information, namely:

"The Lai Autonomous District Council, Education and Human Resources Department (Group 'B' & 'D') Recruitment Rules, 2020"

THE LAI AUTONOMOUS DISTRICT COUNCIL, EDUCATION AND HUMAN RESOURCE DEPARTMENT (GROUP 'B' & 'D') RECRUITMENT RULES, 2020.

To bring national standard and benchmark of teacher quality in the elementary education.

Whereas it is expedient to provide rules for recruitment under Education and Human Resources Department to ensure that the person recruited possesses the essential qualification to meet the challenges of teaching at the elementary school level.

And whereas by virtue of the powers conferred by sub-paragraph (1) and (2) of Paragraph 6 of the Sixth Schedule to the Constitution of India, read with the Governor of Mizoram's Notification No. B.20013/3/94-EDN of 1st August/94 (Transfer of all Government and Non-Government Middle Schools in existence as on 1st April 1994 in Chhimtuipui District to the three respective Autonomous District Councils), the Lai Autonomous District Council is empowered to make the following rules for regulating the method of recruitment to the posts specified in the Annexure.

Now, therefore in exercise of the said powers and other powers enabling it in that behalf, the Lai Autonomous District Council is pleased to make the following rules.

1. Short title and commencement:-

- (1) These rules may be called the Lai Autonomous District Council, Education and Human Resources Department (Group 'B' & 'D'), Recruitment Rules, 2020.
- (2) They shall come into force on the date of publication in the Mizoram Gazette.

2. Application:-

These rules shall apply to the posts specified in column 1 of Annexure annexed.

3. Number of posts, classification and pay level / matrix -

The number of the said post(s), their classification and pay level/matrix attached thereto shall be specified in columns 2-4 of the said Annexure.

4. Method of recruitment, age limit and other Qualification etc:-

The age limit, qualification and other matters relating to the said post shall be as specified in column 5 to 13 of the aforesaid Annexure:

Provided that the age limit prescribed for direct recruitment may be relaxed in the case of candidate belonging to the Schedule Castes/ the Schedule Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualification -

No person:

- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of this rule.

6. Training and Departmental Examination:-

Every person recruited under these rules shall undergo such training or pass such departmental examination as may be prescribed by Executive Committee of the Lai Autonomous District Council from time to time.

7. Power to relax:-

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the concerned Executive Committee relax any of the provisions of these rules with respect to any class or category of persons.

8. Reservations and other Concession -

Nothing in these rules shall affect any reservation or other concession required to be provided for the Scheduled Tribe/the Scheduled Castes and other categories of persons in accordance with the order issued by the Central Government or Government of Mizoram from time to time in this regards.

9. Repeal and savings:-

All rules pertaining to these posts framed by the Lai Autonomous District Council under Notification No. A.12018/1/2011-DCA/L, dated 28th February, 2014 stand hereby repealed with effect from the commencement of these rules:

Provided that any order made or anything done or any action taken under the rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
