## A RULES

Further to amend the Lai Autonomous Council (Group A,B,C&D Posts) Recruitment Rules, 2014 (Herein after to as the Principal Rules)

Be it enacted by the Lai Autonomous District Council in the Sixty Seventh years of the Republic of India as follows:

- Short title and . 1. commencement
- These Rules may be called the Lai Autonomous District Council, (Group A, B, C & D posts) Recruitment (First Amendment) Rules, 2016
- 2. It shall come into force on the date of publication in the Official Gazette of Mizoram.
- Amendment of schedule XX

3.

a) In column 1 of Schedule XX of the Principal Rules, for the word 'Judicial Officer', the word and figure '4. Judicial Officer (Entry Grade)' shall be substituted.

- In column 7 of Schedule XX of the Principal Rules, the words and figures 'Between 18-30 years of age. The upper age limit shall be relaxable upto 5 years for SC/ST' shall be substituted by the words and figure 'Not more than 35 years of age, the upper age limit shall be relaxable upto 40 years of age for candidates belonging to Schedule Caste and Schedule Tribe'.
- c) In column 8 of Schedule-XX of the Principal Rules, for the word 'local' which appear between the words 'of' and 'language', the word 'Lai' shall be substituted.
- 4. Above Serial No.4, as newly amended under Rule 3 of these Rules, Serial No. 1, 2 and 3 shall be inserted as follows.
