The 1<sup>st</sup> April, 2015.

A comprehensive legislation focusing on prevention of Sexual Harassment as well as providing a redressal mechanism has been enacted by the Govt. of India. The "Act Sexual Harassment of Women at workplace (Prevention, Prohibition and Redressal) Act, 2013 (14 of 2013)" has been published in the Gazette of India 23.04.2013. The Govt. has also made rules called "Sexual Harassment of Women at Workplace ) Prevention, Prohibition and Redressal ) Rules 2013. The Act is framed on the basis of guidelines framed by the Hon'ble Supreme Court in the case of Vishaka vs State of Rajasthan which was until now, the only law dealt with sexual harassment cases apart from certain provision of the Indian Penal Code.

Whereas Sub-Section 4 of Chapter - II of the said Act empowered the employer of a workplace to constitute a committee to be known as the Internal Complaints Committee.

Now, THEREFORE, by virtue of the said Act, the Executive Committee of Lai Autonomous District Council, in the public interest to do so, hereby constitutes an internal complaints committee under LADC with the following composition of members as indicated below for a period of 3 (three) years with effect from the date of issuance of their order :
